Re London letter 10/22/63 and Bulet 11/5/63.

With reference to New York LHM dated 10/14/63 concerning D. F. BOCK, P. DEEGAN and one "PEGGY", British Security Service, MI-5, by letter dated 11/5/63, classified SECRET, advises it has no record of DEEGAN and BOCK. MI-5 has made some inquiries concerning them but has not been able to obtain confirmation that any persons with these names stayed at the hotels mentioned during August and September, 1963. (S)

Regarding "PEGGY", MI-5 by letter dated 10/31/63, classified SECRET, advised she is presumably identical with PEGGY PINCKHERD, whose true name is MARGARET MARY JOAN AGNES PINCKHEARD, usually known as Mrs. PEGGY PINCKHEARD, residence 3 Heathview, Gordon House Road, Kentish Town, London NW 5. PINCKHEARD is a fairly long-standing member of the Communist Party who has held in her time a number of minor Party posts at branch level. She visited Peking for a month in October/November, 1952, for the Peking Peace Conference and has been active in the Britain-China Friendship Association since that time. Her husband, REGINALD ARTHUR PINCKHEARD, also has a fairly long record of Communist Party membership. (S)

This matter will continue to be followed with MI-5 and the Bureau kept advised. (S)
