The Special Agents who observed the subject on 10/5/63 were DANIEL A. FLYNN and RICHARD M. MOWRY, JR.

Referenced NY airtel points out that the subject is alleged to have had a meeting with TANG Ming-chao, the head of the American Department of Chinese Communist Party and head of the political intelligence for the Chinese as it relates to Communist Parties in English speaking countries.

Observations

The comments of the NYO concerning the subject's and his wife's involvement in Chinese intelligence activities are as set out in referenced NYlet.

Recommendations

The services of NY 4047-S* will be continued as this source furnishes information concerning the day-to-day activities of both the subject and his wife.

A mail cover will be instituted at the subject's office at 39 Cortlandt Street, NY, NY.

The NYO will give consideration to the development of a highly confidential source at the subject's office after he has occupied it long enough to be fully utilizing it. It is to be noted that information has been received to the effect that he has not as yet finished fixing it up.

The NYO contemplates the establishment of a stationary plant to assist in identifying the contacts of the subject and his wife and also to make fisurs of
