Captioned subjects are on Security Index. They are suspected of being Chinese Communist agents. During 9-63 Richard Frank suddenly departed U.S. for approximately two weeks in London. NY 694-5° later advised Frank was in contact with Jack Perry, a British Communist; TANG Ming-chao and Israel Epstein, both of whom are Chinese Communist Intelligence agents sharing Perry's office. This data could not be disseminated to Britishkin order to protect NY 694-5°. A source of New York Office made available names contained in address book belonging to Richard Frank. Using information furnished by this source as a basis for investigation, we can now logically request British to conduct desired investigation.

Memorandum classified "Confidential" as disclosure of information furnished by 4112-5° could reasonably result in identification of a confidential source of continuing value and compromise its future effectiveness. First source mentioned in memorandum is NY 4112-5°, the second source is CSNY 3 (100-339235-139).
