

Administrative Data

Information is being set forth in this report, which information was furnished by PH 251-C (deceased), during a period from 1946 to 1960. This information concerns his knowledge of the Italian underworld group, known to him as, most frequently, "The Organization," and at other times as "The Syndicate," "The Combination," or "The Mafia." He insisted that this group is the American branch of the Mafia and obtained his information from personal knowledge of the Mafia when he was in Italy and, although he was not a member, a close association of many years with powerful members in the United States. It will be noted that his description of membership requirements, leadership, and activities is, in most part, the same as that furnished more recently by other sources concerning "La Cosa Nostra."

The referenced report contained information furnished by PH 599-C-TE to the effect that "La Cosa Nostra" originated in Sicily hundreds of years ago and that it is the same organization that has been referred to for many years in Italy and Sicily as "The Mafia."

It is pointed out that many questions are as yet unanswered that PH 599-C-TE might be willing to answer. The conditions of interview are such, however, that it is not possible to conduct the exhaustive type interview that is desired.

As indicated in Philadelphia letter to Bureau, dated 10/4/63, information that could be given to him has been furnished to Commissioner HOWARD R. LEARY of the Philadelphia Police Department, said information pertaining to some phases of the "La Cosa Nostra" in the Philadelphia area.

Shortly after publicity began to appear concerning "La Cosa Nostra" as a result of the testimony of JOSEPH VALACCHI,
