Ontario Provincial Police, Kingston, Ontario, Canada, recommended placing an all points bulletin through the General Headquarters Commissioner OPP, 125 Lake Shore Boulevard East, Ontario, Canada, for the red Cadillac convertible being used by Grossi. Grossi allegedly purchased tires for this Cadillac in Renfrew, Ontario, Canada, in approximately March, 1964. A photograph of Grossi attached for information.

Request contact and interview with Cecil Chernik, Doctor H. L. Tracy and Vern S. Ready in an effort to locate Grossi. For the same purpose notices should be placed with appropriate authorities to locate 1963 red Cadillac convertible and a lookout placed with the General Headquarters Commissioner OPP as suggested.
