RICARDO MORALES NAVARRETE WAS FIRST OPERATED AS A SOURCE OF INFORMATION BY THE MIAMI OFFICE IN DECEMBER, 1960. HE WAS DISCONTINUED IN JANUARY, 1961, WHEN HE MOVED FROM THE MIAMI AREA. THEREAFTER, CONTACT WITH MORALES WAS ON AN INTERMITTENT BASIS FROM 1960 THROUGH 1968. IN NOVEMBER, 1968, HE TESTIFIED IN AN OPEN COURT AGAINST ORLANDO BOSCH, WHICH TESTIMONY EXPOSED MORALES AS AN FBI INFORMANT AND RESULTED IN BOSCH'S CONVICTION. MORALES WAS OPERATED AS A SOURCE OF INFORMATION BY MIAMI FROM NOVEMBER, 1968, UNTIL AUGUST, 1975, WHEN HE LEFT THE U. S. FOR VENEZUELA.

[REDACTED] WAS OPENED AS A POTENTIAL SECURITY INFORMANT OF THE CLEVELAND OFFICE IN OCTOBER, 1961. THIS CASE WAS CLOSED IN JANUARY, 1962. [REDACTED] WAS CONTACTED BY THE CLEVELAND OFFICE ON THREE OCCASIONS THEREAFTER AT HIS REQUEST. HE WAS LAST CONTACTED IN NOVEMBER, 1962.
