Attached teletype furnishes information reported by [SJ 1668-S] on 10/20/76 to the effect that Coordinacion de Organizaciones Revolucionarias Unidas (Coordination of United Revolutionary Organizations) (CORU) under the leadership of Orlando Bosch Avila was responsible for the crash of the Cubana Airlines DC-8 on 10/6/76. (X)

CORU is an umbrella group composed of five anti-Castro, Cuban exile, terrorist organizations.

A total of three anonymous phone calls were received by Miami, Florida, news media claiming credit for this terrorist act. Two calls were made claiming credit in the name of the "Condor" organization. The second of these calls appeared to be triggered by a call which claimed credit in the name of CORU. This second call directed news media to a "Condor" communique located in a Miami newsstand which described the method and explosive charge used in the bombing and called for CORU to retract its claim for credit.

We were not aware of the existence of a "Condor" organization. Attached explains that CORU uses different names such as "Condor" to take credit for "military operations" within the U. S. with the (X) (u)
