JOANN OMANG, WASHINGTON POST CORRESPONDENT, TODAY (FRIDAY) CALLED EMBASSY INFORMATION OFFICER TO ASK ABOUT LEGAL ATTACHE JOE LEO'S ASSOCIATION WITH HERNAN RICARDO LOZANO, ONE OF TWO VENEZUELAN BEING HELD IN TRINIDAD. EMBASSY INFO THAT "MR. LEO KNEW RICARDO CASUALLY OVER A PERIOD OF YEARS. HE FIRST WAS CONTACTED BY RICARDO ABOUT TWO YEARS AGO ASKING FOR ASSISTANCE WITH A VISA CASE. LAST TIME HE SAW HIM WAS THE END OF SEPTEMBER OF THIS YEAR WHEN HE ASKED FOR A VISA FOR HIMSELF. RICARDO TOLD MR. LEO THAT HE WAS ON AN ASSIGNMENT FOR VISION MAGAZINE AS A PHOTOGRAPHER AND HAD TO TRANSIT NEW YORK AND PUERTO RICO.
