On 7/26/62 JOSEPH PETER MANNARINO, aka. advised SA JOHN C. MOE, San Diego, that LEON LEWIS, a Certified Public Accountant with offices in the Milan Building, San Antonio, Texas, has performed accounting work for BILLIE SOL ESTES and LEWIS had information concerning the illegal manipulations of ESTES. MANNARINO did not disclose the source of his information and stated he knew nothing further concerning this matter.

MANNARINO, FBI No. 4387400, is brother of Pittsburgh hoodlums GABRIEL and SAM MANNARINO. He is a former PCI of the San Diego Office. He has been in the Pittsburgh area for about the past six months and has recently returned to Southern California. MANNARINO is the con man type. He frequently exaggerates and makes statements which cannot be substantiated concerning his associations with influential people and underworld characters. He drinks heavily and suffers from a spastic condition, which makes it difficult to understand him.

MANNARINO has no current fixed place of residence. He moves frequently and is indebted to several expensive motels and bars in the San Diego area.
