Investigation has determined that this individual is FRANK S. BERNARD, owner of the Bernard Food Industries, 1208 East San Antonio Street, San Jose, California. SF-2354-C on April 16, 1962, advised that FRANK BERNARD is known as DR. BERNARD to his close friend and associate, RAY BILY, owner of the Alum Rock Cheese Company of San Jose. Informant advised that DR. BERNARD often is seen at the Paolo's Restaurant, which is frequented by members of the ISO. He stated that to his knowledge, BERNARD is not a member of the ISO. SF\_\_\_\_\_C-TE has furnished no additional information to indicate that BERNARD is, in fact, a member of the ISO of San Jose. In view of the result of inquiries made, no report concerning FRANK S. BERNARD is being submitted, UACB.
