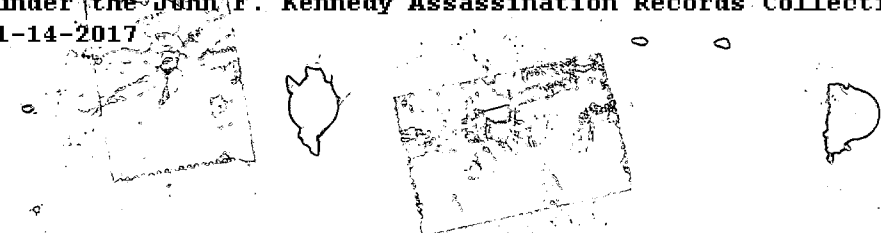

ANGELO BRUNO, AKA., AKA. RE LEGAT, LONDON LET DATED APRIL TWO SEVEN, ONE NINE SIX ONE. RELET RELATED [SUBJECT RECEIVED PAYMENT FOR DAMAGES TO GAMBLING CASINO, PLAZA HOTEL, HAVANA, CUBA. CLAIM PRESUMABLY PAID BY AMERICAN INTERNATIONAL REINSURANCE CORP., NYC.] NYO DETERMINED C. V. STARR CO., NYC, INSURED INSTANT CASINO THROUGH ITS SUBSIDIARY, AMERICAN INTERNATIONAL REINSURANCE CORP, WHICH WAS NATIONALIZED BY CASTRO GOVERNMENT, OCTOBER TWO FIVE, ONE NINE SIX ZERO, AND PAID CLAIM FOR APPROXIMATELY ONE EIGHT ZERO OR ONE NINE ZERO THOUSAND PESOS IN APRIL, ONE NINE FIVE NINE, AT WHICH TIME PESO HAD SAME VALUE AS DOLLAR IN EXCHANGE. 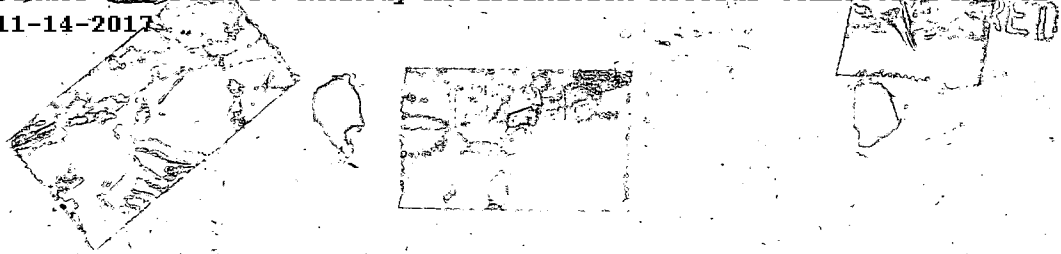

 HANDLING REQUESTED SINCE BRUNO DESIGNATED BY DEPARTMENT AS TARGET
 FOR EARLY PROSECUTION AND CASE RECEIVING INTENSIVE INVESTIGATION.] (C)

NOTE Angelo Bruno is national top hoodlum designated for early
 prosecution, case receiving intensive investigation at this time.
 Possible prosecutable offense developed by PH as investigation
 determined Bruno received payment of \$180,000 or \$190,000 for
 insurance claim for damage to gambling casino when Castro Government
 seized it. [Records for possible trial located in Cuba. Legat being
