During the period from October 12 to October 27, while the Olympic Games were being held in Mexico, D. F. all PCM activity in Coahuila was suspended. (c)

On November 3, 1968, the Coahuila State Committee held a meeting where they discussed the student strike situation. At this meeting, it was stated the student strike had caused a discussion in the Chamber of Deputies of the possibility of eliminating Article 145 from the Penal Code of Mexico and it appeared this would be accomplished and this is an objective the PCM sought for many years. They discussed the strike situation in Mexico City and it was stated it was likely it would be resumed in full force. In regard to the strike in Coahuila, the students are returning to their classes but will continue to support the strike in Mexico City. It is not known the form of the support to be given as yet as this is still under discussion. (c)  
They planned a celebration of the anniversary of the Russian Revolution (c)
