though he had been unable to reach "MICKEY" in Mexico City, he had received the impression from the officials he spoke to there, names not recalled, that he would again be welcome to visit there and discuss intelligence matters.

ECHARTE advised that he does not know the identity of a single CIS agent currently operating outside of Cuba. He noted, however, that it is his assumption that personnel working in various Cuban Diplomatic and Consular Offices throughout the world definitely include G-2 agents.

ECHARTE disclaimed knowledge of any Cuban G-2 intelligence agent or agents working in the WDC area and said he could think of no one who would fit the description of an individual who had been described as code name G-11; a 48-50 year old male, sometimes referred to as "EL VIEJO"; a person regularly dependent upon medication, effeminate in appearance, and one who has been targeted against Cubans close to former President RICHARD M. NIXON and his entourage, including BEBE REBOSO. ~~(S)~~ (S) (U)

In attempting to recall any individual known to him throughout his association with CIS who was effeminate and who would come close to the preceding description, ECHARTE related the following: Although ECHARTE could not recall his name, he stated that in approximately 1959, RAMIRO VALDEZ, a high CASTRO Official, had a top lieutenant who supposedly was effeminate. This individual would be about 50 years old today. When ECHARTE knew him, he had reddish or blond hair, was about 5'6", weighed approximately 155 pounds, was well educated and had fought in the mountains with CASTRO. ECHARTE said he had no information indicating this individual had ever been on assignment for CIS in the United States or elsewhere and advised he could furnish no additional information concerning this individual or his activities. ECHARTE categorically denied ever having worked in the State of Florida or the Talisman Sugar Corporation at their sugar mill in Belle Glade, Florida. He affirmed that he did not know JOSE CALIXTO SANTIAGO VALDEZ nor had he heard of any CIS interests in any one associated with the Talisman Sugar Corporation. In this regard, ECHARTE further stated he did not know PEDRO ANDRES PELEGRINO and had no idea why any CIS agent might have been targeted against this individual. ~~(S)~~ (U) (S) (U) (S) (U)
