Enclosed for the Bureau are the original and 5 copies of a blind memorandum for dissemination to the [British.]

INS, Miami, had no objection to our use of the information set forth in the enclosed memorandum. INS advised that WHITEHOUSE is presently the beneficiary of a private bill which was introduced in the U. S. House of Representatives, first session of the 88th Congress, to give him U. S. citizenship. INS also indicated that they believed WHITEHOUSE is already in Jamaica in connection with establishment of this airline. As noted in enclosed memorandum, WHITEHOUSE has already been granted a permit to re-enter the U. S., valid to 12/31/64.

Information from Miami file 26-27590 not included since it relates to a possible [CIA operation] in which WHITEHOUSE is involved.

The source utilized in the memorandum is MM 660-C.

Attached is copy of communication dated 2/10/64 received from MI-5 (British Intelligence), the contents of which are self-explanatory. (c)

The information in first paragraph of enclosure refers to list Bureau obtained from INS and furnished MI-5 after receiving authorization. A copy of this list was furnished your office by letter dated 1/4/61, captioned "Anti-Fidel Castro Activities." (c)

Check with INS locally to determine whether subject's name is still included in the Notice of Prevention of Departure list and advise Bureau.

Carefully review your files and submit succinct summary of the pertinent data available concerning subject originating with Bureau sources and informants in memorandum suitable for dissemination to British. (c) This should be blind memorandum and prepared on unwater-marked paper. The information from Bureau sources and informants should be set forth as is normally done in memorandum prepared for dissemination; however, in those cases where we would normally identify the source, in this instance, since the data is being furnished a foreign intelligence agency, such sources should be appropriately described in the memorandum but their identities set forth in the administrative pages accompanying the memorandum.

If any information is incorporated in the memorandum which originated with another Government agency, specific authorization must be obtained from the Government agency involved prior to incorporating the material in the memorandum. If such authorization is obtained, it must be specifically noted in the cover communication accompanying the memorandum.

Anti-Fidel Castro Activities.

Please refer to your 13330 dated 4th January 1961, with which you forwarded a copy of an I.N.S. list of persons who had been served with a "Notice of prevention of departure".

2. Our office in Jamaica have informed us that an application has been received by the Jamaican Government for a visa for Edward J. WHITEHOUSE, born 14th March 1914, to come to Jamaica as supervisor of an airline which operates between Jamaica and Venezuela. Subject is apparently a Cuban and his visa application was accordingly referred to our office in Kingston.

3. In view of the fact that subject appeared on the Immigration and Naturalisation Service's black list, Jamaica is not keen on having him there if it is still the view of the United States authorities that he justifies retention on the black list.

4. We shall be grateful if this can be checked and if we can be told what information available may be passed to the Jamaican security authorities.

5. It would seem that refusal by Jamaica of a Cuban visa application would not endanger sources but should Jamaica decide to do this in respect of a person on the I.N.S. black list presumably covering approval from I.N.S. should first be obtained. We shall be grateful for your comments.
