The "Diplomatic List" published by the Department of State for October 191960, lists Avraham Salmon as Economic Counselor at the Embassy of Israel, Washington, D.C.

According to the informant, Davidson and Salmon had discussed a matter previously which indicated there was a third party who was unknown to the informant and for whom Davidson was attempting to negotiate a sale of gold. Salmon however, reported that Mr. Sidney Green associated with the Streasury of Israel in New York, New York, is the only person suthorized by the Treasury of Israel to deal in such matters.

Salmon also felt that the third party may not desire to deal directly with Green. If this were the case, Salmon advised, there would be no deal.

Davidson has indicated that his only mission is to determine the amount Green's willing to offer for the gold. Davidson also advised that he will contact Green's irectly and will prove he is working in the best interests of the Government of Israel and will attempt himself to determine the amount of money Green will offer.
