JOSE SIORDIA JIMENEZ OF FEDERAL JUDICIAL POLICE AT
GUADALAJARA ADVISES HE WAS PRESENT AT ARREST OF JAY BLAND ON
MARCH 29, 1973. BLAND WAS SELLING CONTRABAND ARTICLES.
BLAND WAS ASKED, "WHERE IS YOUR AUTOMOBILE," AT WHICH TIME
HE TOOK ARRESTING AGENTS TO HIS AUTOMOBILE WHICH WAS PARKED
ABOUT TWO BLOCKS AWAY. THIS AUTOMOBILE DETERMINED TO BE
1970 OLDSMOBILE BEARING SERIAL 348650M190077 AND NEW YORK STATE
LICENSE PLATES 8991GX. PARTICIPATING IN ARREST OF BLAND WAS
FEDERAL JUDICIAL POLICE AGENT VINCENT YLLAN GARCIA. SIORDIA
STATED HE COULD TRAVEL TO MIAMI TO TESTIFY TO ABOVE AND WOULD
CARRY COPIES OF DOCUMENTS REFLECTING ABOVE INFORMATION.
