Re Philadelphia airtels 11/22; 12/6,9/57, and Miami airtel 12/4/57.

PH 269- advised on 1/9/58 that on evening of 1/3/58 he received a call from ANGELO BRUNO (Top Hoodlum, Philadelphia Division) from Miami, Fla. BRUNO advised informant that Florida State Senator and attorney NORMAN F. HAFT, Miami, wanted 20 per cent of profit per year for securing trash contract. BRUNO asked informant if he should "go ahead with the deal." Informant instructed BRUNO to telephonically contact him on the evening of 1/4/58.

PH 269-C said on evening of 1/4/58 BRUNO again called him, at which time he, informant, instructed BRUNO to go ahead with the arrangements previously discussed, although he considered 20 per cent to be exorbitant fee.

Informant stated that from discussion with BRUNO he had determined that contract will be secured by the Senator and will be awarded in the name of BEN GALLUP (Phonetic). Informant states GALLUP operates the juke box business for the Italian element in Miami. BRUNO told the informant

that GALLUP's affiliation with the racket element in the Miami area is not generally known, and he is considered "clean."

PH 269-C said BRUNO instructed him that contract will probably be awarded in approximately 45 days, and that he, BRUNO, would not consider the deal without informant's okay.

Informant stated that BRUNO told him on the evening of 1/4/58 he was going to Havana and would return to Philadelphia on 1/13/58. BRUNO stated he would contact the informant on that date.
