No reply submitted to first airtel, inasmuch as a PCI with whom contact is desired for information concerning this matter, has not returned from the United States.

Contact with informants and other sources in a position to have knowledge of Teamsters Union, Local 901, activities and hotel affairs in the Puerto Rico area, have been negative to date. San Juan files contain nothing pertaining to the allegation that CHAVEZ attempted to shake down the owners of four hotels.

It is noted that in March, 1962, JAMES R. HOFFA and EDWARD MILLER, of the International Hotel and Restaurant Workers and Bartenders Union of Cincinnati, Ohio, signed a mutual aid pact applying to Local 901, Teamsters Union, San Juan, Puerto Rico, and Local 610, Hotel and Restaurant Workers Union, San Juan, Puerto Rico, wherein it was agreed that Local 901 would desist from further attempting to organize the hotel industry in Puerto Rico, would turn over to Local 610 any hotel employees that were then members of Local 901 in exchange for a Local 901 organizer, LEOPOLDO RAMOS-DUCOS, being appointed as trustee, which was placed in effect. Subsequently, the Puerto Rican Senate Labor Committee
