On 4-21-67, former WF 1633-C-TE advised SA RICHARD T. MARQUISE as follows, when contacted on another matter:

MARCELLO has been attempting to have the new stadium for the New Orleans Saints football team located on property owned by him. MARCELLO has indicated he would donate the necessary land for the stadium inasmuch as it would greatly increase the value of a large parcel of adjoining land owned by subject.

Source also advised that WDC attorney, JACK WASSERMAN, is currently involved with subject in land deals in the New Orleans area. WASSERMAN's wife reportedly has been going to New Orleans frequently. She allegedly calls down "on the spur of the moment," advising that she is coming and is then entertained by the MARCELLOS. Source indicated the MARCELLOS feel Mrs. WASSERMAN is a burden with her frequent trips to New Orleans.
