NO 1457-C-TE advised that CARLOS MARCELLO's wife JACKIE recently imposed an 8:00 p.m. curfew on CARLOS MARCELLO when he is in New Orleans. JACKIE MARCELLO has become highly incensed over CARLOS MARCELLO's long time affair with LUCILLE, the beautician. JACKIE MARCELLO has never before become upset with any of MARCELLO's other female companions but his association with LUCILLE has really upset JACKIE MARCELLO.

Approximately two and one-half weeks ago, the first night of the curfew, CARLOS arrived home one-half hour late. CARLOS MARCELLO's daughter was swimming in their pool with several of her girl friends, including two overnight guests. JACKIE MARCELLO would not let CARLOS in, and several moments later ordered all the girls into the house but barred the door to CARLOS MARCELLO.

CARLOS MARCELLO became enraged and obtained a sledgehammer from the garage with the intention of breaking down the door. JACKIE MARCELLO took a shotgun and pointed it out a second story window and ordered CARLOS off the property. JACKIE told CARLOS to come back the next day or whenever he felt he could stick to the curfew. Since that incident, CARLOS has been sticking to the curfew and when in New Orleans, is only out after 8:00 p.m. when accompanied by his wife.
