On 8/10/67, NO 1435-C-TE advised that CARLOS MARCELLO was in Covington, La., the night of 8/9/67. MARCELLO accompanied by WARREN ~~RAY~~, Jefferson Parish realtor; MIKE (LNU), owner of Jefferson Parish exterminating company; RONNIE (LNU), Professor of English, Louisiana State University at New Orleans. RONNIE (LNU) is working on a research paper and presentation paper regarding the site of the dome stadium in New Orleans. Informant stated that MARCELLO definitely feels he is in the running to have the dome stadium built on his property at Churchhill Farms.

At approximately 1:00 a.m., 8/10/67, JOSEPH MARCELLO, accompanied by MARIO MARINO, arrived at CARLOS MARCELLO's Covington home. Both MARCELLOS and MARINO had a brief private conversation during the middle of which CARLOS MARCELLO shouted "I will have to go up there and take care of that s.o.b." Informant does not know what this conversation was about.
