On August 3, 1967, Bos'n GEORGE S. LEE, United States Coast Guard Station, advised that CARLOS MARCELLO is a frequent visitor to Grand Isle. LEE does not know where he stays while visiting the island. LEE stated that, during the recent Tarpon Rodeo, NAT CHIGHIZOLA, Public Relations Director for Grand Isle, telephonically contacted the Coast Guard Station and asked an unknown Coast Guardsman to go down to the Marina and pick up CARLOS MARCELLO and give him a ride to an unknown destination. According to LEE, MARCELLO was temporarily stranded on the dock and had called CHIGHIZOLA for a ride, presumably to his camp.

LEE stated that he has heard, at the Coast Guard Station that, when the Coast Guard vehicle arrived on the dock and the Coast Guardsman approached MARCELLO and told him to get into the vehicle, MARCELLO became very scared and said, "I surrender peacefully". The Coast Guardsman then explained to MARCELLO he was merely giving him (MARCELLO) a ride. This relieved MARCELLO. LEE will attempt to identify this Coast Guardsman.

On August 4, 1967, Deputy Town Marshal, AMBROSE BESSON, advised that CARLOS MARCELLO has been frequenting Grand Isle for over 20 years and that he is well-known and well-liked on Grand Isle. He stated that MARCELLO's closest friend on Grand Isle is NAT CHIGHIZOLA. BESSON stated that CHIGHIZOLA was married in November, 1966, to DOLORES OLSON, Gwner, Snak Shack, Grand Isle. CARLOS MARCELLO was NAT CHIGHIZOLA's best man and CHIGHIZOLA and his wife honeymooned at MARCELLO's Churchill Farms Estate. CHIGHIZOLA is the Public Relations Director for Grand Isle and owns the Nez Coupe Souvenir Shop on Grand Isle. BESSON stated that Nez Coupe was a lieutenant of Jean Lafitte, the well-known pirate of the nineteenth century in Louisiana, and CHIGHIZOLA is a direct decendent of Nez Coupe.
