Re New Orleans telephone call to Bureau, 1/12/68.

NO 1435-C-TE telephonically advised today that CARLOS MARCELLO had called him this morning and invited him to join MARCELLO in attending the Super Bowl in Miami, Fla., on 1/14/68.

MARCELLO advised informant that informant would accompany MARCELLO and MARCELLO's son JOSEPH on a flight to Miami during the early morning of 1/14/68. MARCELLO indicated that they would be there for several days and that MARCELLO had to contact several people in the Miami area.

It is anticipated that MARCELLO will contact SANTO TRAFFICANTE, JR., while in Miami and probably other leading hoodlums in the Miami area.

On 1/4/68, Bureau authorized an expenditure of an additional \$200 for this informant. \$100 was paid to this informant on 1/9/68.

Per phone call to Bureau, the remaining \$100 and an additional \$200, as telephonically requested, being furnished to the informant on 1/12/68, for expenses that he will incur on this trip with MARCELLO.
