The Direction de la Surveillance du Territoire (DST), French domestic counterespionage service, on July 30, 1964 advised that the captioned subject, born August 22, 1922 at Rochester, New York, gave his occupation as a film director and his residence as 110 Christopher Street, New York, New York, lodged at the Hotel Louvois, rue Lulli, Paris 2, on May 17, 1964. He was traveling alone and made no contacts while staying at the Hotel Louvois. The DST has found no record of a visit to Paris of the subject's wife, MILDRED FRANK, or of TANG Ming-chou alias CHU Tong
