CG 5824-S\* advised that the subject and his wife SUE FRANK planned to leave the U.S. at the end of October 1959 on their way to China. His wife had been invited to work on the "Peking Review" in China for two years.

\*BA 975-S\* advised on 8/8/61 that early in May, 1961 the subject and his wife were in Moscow having gone there recently from a trip to China.

The subject was observed by Special Agent of the FBI on September 13, 1963 to board BOAC Flight 506 which left New York at 10:00 PM and was scheduled to arrive in London at 9:35 AM the following morning.

NY 694-S\* advised on 11/3/63 that ~~TAN~~ TAN Ming-chou stated that he is in close touch with the American scene through the subject and another individual. He stated that the subject travels to London repeatedly to contact him.

Foreign

TANG is reported to be head of Political intelligence in English speaking countries for the government of Communist China.

NY 4112-S\* advised in 8/63 that the subject is known to and has been in contact with TANG Ming-chou.

A review of the records of INS, NY show that the subject was aboard Alitalia flight 603 on May 4, 1964, destined for Milan, Italy.

NY 4047-S\* advised on May 5, 1964 that the subject's wife, SUSAN H. ~~FRANK~~, stated that her husband was out of town for a few days as he had some business that took him away.
