On 11/13/64, L. G. BOWLING, Owner, Town-O-Tel
Motel, 409 Thorn Street, Princeton, W. Va., advised
SA JOHN J. RUTLAND that motel records reveal that
RICHARD C. FRANK, 110 Christopher Street, New York,
N. Y., was registered on 8/17/64, for one day only.
He was alone and was assigned Room 15.

The record revealed that while at the motel,
FRANK made two long distance telephone calls:

1. "PERTHAMBON" (possibly Perth Amboy),
N. J., telephone number HI 2-4467
2. Rochester, N. Y., no number shown

Credit card #040-244-892-2 was utilized to
pay for the above phone calls.

On 12/3/64, TOM MC CUTCHEON, Commercial
Supervisor, General Telephone Company of the Southeast,
Princeton, W. Va. (protect identity in view of position),
advised SA RUTLAND that on 8/17/64, a call was made
from Town-O-Tel Motel, 425-3585, to Rochester, N. Y.,
telephone number 244-3625. The call was of eight
minutes duration and the name of the party called
was not shown.
