The Veterans' Administration file on John Jesse Morgenstern reflected that on 6/12/49, he was married to Kathleen Amy Harris, 155 Norfolk St., NYC. Richard C. Frank, 496 Hudson St., NYC, was a witness to this marriage. At that time Morgenstern gave his address as 496 Hudson St.

Correlator's Note: According to the main file on Frank, he and Morgenstern lived in an apartment at above address for the period of approximately 1948-1950. An informant described Morgenstern as an avid communist.

NY 649-S\* advised in January, 1953 that one "Dick", who resided at 65 Morton St., NYC, invited a Jimmy MacDonald to stay with him at the above address. Informant advised that "Dick" was at Rose Kryzak's house on that date. In an effort to identify "Dick" and Jimmy MacDonald, Lloyd E. Elwyn, superintendent at 65 Morton St., was interviewed. Elwyn advised that Richard Frank and John Baker resided at that address in apartment 6H, that Frank received the "DW" and the "National Guardian", and that he, Elwyn, considered Frank to be a communist. Elwyn stated that Frank's girl friend was Avis Delman, who resided in apartment 6K at that address. Elwyn furnished a description of Frank and stated Jimmy MacDonald had not lived at that address.

On 2/14/53, NY-649-S\* reported that Rose Kryzak had contacted one "Dick" at 18 West 30th St., NY, and it was ascertained that this individual was not identified with the Dick at 65 Morton St.
