Records of the Union Bank, Los Angeles, concerning the "EMANUEL ROTHMAN, Trust Account" which is used by EMANUEL ROTHMAN, ROSSELLI's attorney and accountant in connection with some of ROSSELLI's financial activities, reflect that during the past month no checks were drawn on this account and only one deposit was made. The deposit was a \$2,000 check drawn by ROSSELLI on his account at the Fidelity Bank, Beverly Hills, California.

ROSSELLI has resided at his Los Angeles apartment during the past week, although his girl friend, KATHY HORDEN left Los Angeles for Las Vegas on Monday.

On 10/30/64 former CSLA 4367-C advised that on Sunday, 10/25/64, ROSSELLI came to the Friars Club in Beverly Hills with ADRIAN FINK, attorney for the Sands Hotel in Las Vegas. ROSSELLI and FINK had played golf together on that date.

Investigation has revealed that on 10/29/64 ROSSELLI left the apartment about 11:30 AM in a taxicab and went to a medical building at 9730 Wilshire Boulevard, Beverly Hills, California.
