Rerep of SA John A. Holtzman dated 5/10/62 at Milwaukee and rep of SA James P. Flynn dated 6/29/62 at New York.

The Department in review of rerep of SA Flynn has indicated a desire to have more complete background data on one Angelo Provenzano, who is listed on page 67 of rerep of SA Flynn and who is described as being made good use of by the organization because of his local political connections.

It is noted that on page 11 of rerep of SA Holtzman, MI T-4, who is identified as MI 618-PC, advised SA John H. Gassaway in January, 1958, that one Angelo Provenzano was used by the organization for his connections among local politicians. Milwaukee should recontact MI 618-PC and determine full particulars and background of this Provenzano who allegedly is utilized by the hoodlum organization because of his so-called political connections.
