SF 2550-C-TE advised on 10/3 and 4/63, that about 5:00 A. M., 10/3/63, JOE MARINO, brother of ANGELO MARINO of San Jose, California, contacted informant and advised him ANGELO wanted to see him on important business.

About 10:30 A. M., 10/3/63, informant met with ANGELO MARINO at California Cheese Company, San Jose, California, where he was introduced to a man by the name of VINCE CATANIA (phonetic) from "Philadelphia", and who he introduced as "a friend of ours." The conversation took place in both English and Italian, and CATANIA reportedly spoke English very well. He is described as follows:

ANGELO indicated he had received information that informant had been to see PETE MISURACA; that MISURACA is "crazy" and that PETE had his chance and is a coward. ANGELO did not explain as to just what he meant in this regard, but informant assumed it referred to PETE wanting to travel to Reno, Nevada, and kill HAROLD SMITH and GUY LENT of Harold's Club.

ANGELO turned to VINCE and stated that informant was one of the few persons who could get PETE to follow his instructions, and would be a person who could get close to PETE. ANGELO then told informant that he (the informant) was going to do a job with VINCE. Informant asked if they were going to "bump off" PETE, at which time ANGELO hedged and said "I didn't say that." ANGELO stated that VINCE was leaving town but would return within a week at which time ANGELO would contact the informant.

ANGELO mentioned that informant had not contacted JOE CERRITO at Los Gatos, California, for some time, and indicated that JOE CERRITO wondered if informant was trying to avoid him because the latter owed CERRITO some money on a car purchase. On 10/3/63, informant gave ANGELO \$75.00 to give to CERRITO on payment for the car. Informant wanted to contact CERRITO in person, but ANGELO advised CERRITO was not in town.
