COSA NOSTRA, AR - CONSPIRACY.

OCTOBER 8, LAST, NY 3461 - C - TE ADVISED CHARLES LOCICERO TOLD HIM THE FIVE "FAMILIES" IN NEW YORK HAD POOLED LARGE SUM OF MONEY WHICH IS BEING USED TO BUY PUBLICITY FOR VALACHI AND SENATE HEARINGS. INFORMANT UNABLE TO ASCERTAIN IDENTITY OF ANYONE WHO HAS RECEIVED PAYMENTS IN THIS EFFORT BUT STATED LOCICERO INDICATED CONTACTS BEING MADE WITH PEOPLE IN NEWS MEDIA AND ATTEMPTS BEING MADE TO ESTABLISH CONTACT WITH POLITICAL FIGURES IN EFFORT TO HOLD UP ANY LEGISLATION WHICH MIGHT ARISE AS RESULT OF THESE HEARINGS. INFORMANT ADVISED ABOVE CONVERSATION WAS VERY SHORT AND HE DID NOT HAVE TIME TO FULLY DEVELOP INFO FROM LOCICERO BUT IS CONTINUING HIS EFFORTS TO OBTAIN FURTHER DETAILS.
