RE LA TEL TO DIR THIS DATE AND LA AIRTEL TO DIRECTOR APRIL TWENTY SIXTY SIX. ALL INDIVIDUALS SET OUT IN REAIRTEL INTERVIEWED SIMULTANEOUSLY THIS DATE EXCEPT CATERINA PALAZZO WHOSE WHEREABOUTS UNKNOWN AND MRS. EDWARD G. AYOTTE. MARIA SACCO MOTHER OF SUBJECT STATES SHE ENTERED U.S. IN NINETEEN ELEVEN WITH SON PHILLIPO AND CATERINA PALAZZO, WHO IS DAUGHTER OF UNCLE OF ANTHONY PALAZZO WHO IN TURN IS MARIA SACCO'S BROTHER-IN-LAW. ANTHONY AND HIS WIFE ARE DEAD. WHEREABOUTS OF CATERINA PALAZZO UNKNOWN. MARIA'S HUSBAND VINCENZO SACCO DIED NINETEEN EIGHTEEN. IN NINETEEN TWENTY OR NINETEEN TWENTY ONE SON PHILLIPPO SACCO RETURNED TO ITALY WITH FAMILY FRIEND WHOSE NAME SHE COULD NOT RECALL BUT "MIGHT HAVE BEEN ROSSELLI." HE RETURNED BECAUSE SHE COULD NOT SUPPORT HIM IN THIS COUNTRY. SHE DENIES EVER HEARING FROM HIM OR SEEING HIM SINCE THAT TIME AND DOES NOT KNOW WHETHER HE IS ALIVE OR DEAD. SHE LIVED IN EAST BOSTON AND IN NINETEEN TWENTY TWO REMARRIED TO LIBERATO CIANCULLO. BY THIS MARRIAGE HAD ONE CHILD CARMELLA CARDULLO CHELMSFORD, MASS. SUBSEQUENTLY SHE MOVED TO SOMERVILLE AND LEXINGTON BOTH MASS. SECOND HUSBAND CIANCULLO RETURNED TO ITALY IN NINETEEN TWENTY SIX - NINETEEN TWENTY SEVEN.
