Re Los Angeles airtel to Bureau dated 4/20/66, in captioned case and Los Angeles airtel to Bureau, 4/15/66, in case captioned "LA 4369-PC. TECIP". New York received a copy of both airtels.

For the information of the New York Office, ROSSELLI has been interviewed by Bureau Agents and has refused to be cooperative.

There is enclosed for the New York Office two photographs of ROSSELLI taken in about 1925 and 1930.

On 6/14/66, Agents of the Los Angeles Division interviewed RALPH AVERGA, 1017 South Beacon Street, San Pedro, California. Photographs of JOHN ROSSELLI taken in about 1925 and 1930 were exhibited to AVERGA who stated they were photographs of JOHNNY ROSSELLI. He said he knew ROSSELLI by no other name; that he never knew a SACCO family in Boston, Massachusetts, and had no knowledge that ROSSELLI's true name was FILIPPO SACCO.

AVERGA said he came to the United States with his parents in 1895 when he was two years old. He lived in New
