YEBER INTERVIEWED ON NINE SEVENTEEN SIXTYEIGHT AND CATEGORICALLY DENIED ANY KNOWLEDGE OF BOMBING ACTIVITIES. YEBER CLAIMS HE IS IN MIAMI TO FIND A JOB SINCE HE HAS LIVED HERE IN THE PAST AND LIKES MIAMI AREA. YEBER STATED HE IS RESIDING WITH BROTHER AND STATED HE IS WILLING TO COOPERATE WITH ALL LEGAL AUTHORITIES. HE STATED HE KNOWS BOSCH BY REPUTATION ONLY.

MIAMI WILL CONTINUE TO MAINTAIN PRESSURE ON GROUP THROUGH VIGOROUS INTERVIEWS OF YEBER'S ASSOCIATES. MIAMI WILL CONDUCT SPOT CHECKS ON YEBER AND HIS KNOWN ASSOCIATES AND MAINTAIN CLOSE CONTACT WITH PSI FRANCISCO MOLINA, WHO IS IN DAILY CONTACT WITH THIS GROUP, TO ASSURE COMPLETE COVERAGE OF THEIR PLANS AND ACTIVITIES.

MIAMI IS AFFORDING THIS INVESTIGATION TOP PRIORITY IN VIEW OF BACKGROUNDS OF THOSE INVOLVED.
