PCI BEN J. SHEAR contacted by SA REGIS L. KENNEDY, 2/26/60 and he had no information re subject.

On 2/18/60, SA L. M. SHEARER, JR. contacted PCI RAYMOND L. ROLLING, who advised that SAM GALLO had returned to the rear room of the Town and Country Restaurant and was probably running a relay station for the wire service. ROLLING asked GALLO what he was doing and GALLO said he was working for CARLOS MARCELLO.

PCI PAULINE MORSE was contacted 3/10/60 at Shreveport, Louisiana, and advised SA DAVID P. HURLEY that on the night of 3/9/60, CARLOS MARCELLO was in Shreveport, La. at the Town and Country Motel, 4115 East Texas, Bossier City, La. One of the persons to contact him that night was MERLE KIMMERLY, owner of Sak's, Minden Road, Bossier City.

CECIL GALLASPY, Lake Charles Manager, Southern Bell Telephone & Telegraph Co., Lake Charles (whose identity is being protected at his request), on March 8, 1960, advised telephone number HEmlock 3-5805 is listed to the Snooper's Den, 1011 Enterprise Blvd.
