He pointed out that CISNEROS is associated with the engineering firm of HOWARD POST at 225 Westward Drive, Miami Springs. He said CISNEROS has in recent months traveled to the Dominican Republic, Puerto Rico and Costa Rica, supposedly on engineering matters, although he does not have an engineering background. *u*
