Enclosed LHM is being classified confidential, no foreign dissemination/controlled dissemination, inasmuch as it contains information from CIA so classified. ~~(S)~~(C)(U)

On August 1, 1966, Mr. ALLEN YARBOROUGH, U. S. Customs Agent, Miami, advised that, to his knowledge, there are no 9mm UZI sub-machine guns available in the United States and, to his knowledge, Cuban exiles in the United States do not have any and U. S. Customs has not confiscated any.

Inasmuch as there are no indications that JURE obtained any such arms, this office anticipates no further investigation in this matter.

MM T-1, another Government agency which conducts intelligence investigation, on June 27, 1966, advised that information had been received from a United States citizen, who had long residence in Latin America, and who is trained in the collection of information. This source reported that information was received from a friend of Ricardo Morales Navarrete. (S)(X)(U)

According to Morales Navarrete, a Cuban emigre in Miami, the Junta Revolucionaria Cubana (JURE, Cuban Revolutionary Junta), was planning to attempt to assassinate Fidel Castro Ruz. (S)(X)(C)(U)

On May 31, 1966, Morales received a letter from an unnamed person in Puerto Rico, who is closely associated with JURE, in which Morales was asked to buy two machine guns of European manufacture of the type which are used by the personal escort of Fidel Castro Ruz. He was asked to give the weapons to Osorio Davila Santana, an officer of JURE. Morales was told that the weapons would be needed within 15 days. (S)(X)(C)(U) F/g.

MM T-2, a Cuban exile, and formerly a leading member of JURE, on July 27, 1966, advised that Ricardo Morales Navarrete is a Cuban exile residing in Miami. Morales previously fought in the Belgian Congo along with other Cuban exile volunteers from Miami, and is sometimes called "El Congolese."
