The FBI Laboratory is requested to compare enclosed lottery ticket with lottery tickets previously submitted by IRS to determine if there are indications of interstate transportation.

It is requested this examination include examination of paper, ink and printing. It is also requested that information be furnished as to the possible size of the press printing these tickets.

It is noted that enclosed lottery ticket does not bear staple. In future, specimens will be obtained with staple still present.

Due to the possible involvement of top hoodlum factions such as the MANNARINOS in this lottery operation, expeditious handling of all leads is requested.

All offices receiving copies of this airtel contact established informants in large cities and other localities wherein lottery activities are extensive to determine whether lottery tickets of the above described type or any lottery tickets are available.

Will make efforts to obtain lottery tickets with staple and forward same to the FBI Laboratory for comparison with enclosure and any other submissions pertinent to this case.
