On 9-8-69, former MM 639-S contacted the Miami Office and advised he recently had received a letter from captioned individual. DEMPSEY said he was still residing in Canada and is in association with an American in Ottawa, Canada. This American, not further identified, is writing a book about the assassination of JOHN F. KENNEDY and has been in contact with GERALD PATRICK HEMMING, LORENZO HALL and LARBY HOWARD.

Source explained that HEMMING, HALL and HOWARD are American adventurers and mercenaries and were active in Cuban revolutionary matters in Miami in 1962. are presently residing in the metropolitan area of Los Angeles, California.

Source said he expected to be contacted again in the immediate future by the subject inasmuch as Haitian exile leader, Colonel RENE JUARES LEON, is now out of jail and is interested in continuing in copies ma Maitian revolutionary activities.

Source explained that subject is very loyal review at FBIHQ by to LEON and can be expected to work on LEON's behalf in Canada.

If this source furnishes further information the Bureau will be immediately concerning the subject, notified.
