It is noted that REGO may be a phonetic spelling of the last name of ROGER/RIGAUD, the subject of Miami file 2-332, a well known Haitian revolutionary.

LORENZO HALL may be identical with the subject of Bureau file 2-1693, captioned WALLACE H. WELCH, JERRY PATRICK HEMMING, LORENZO HALL: NEUTRALITY MATTERS. HALL has been described as a typical soldier of fortune, who is irresponsible and wants to fight just for enjoyment. He is said to have been at one time a member of the Cuban Rebel Army and served under CAMILLO CIENFUEGOS, HALL is a self-styled fighter, disagreeable, not liked, with a bad personality and low moral standards. He is loosely associated with Cuban revolutionary activities.

On August 19, 1963, PSI
