On May 15, 1962, BS T-3 furnished the following information, stating that he could prove none of it, but what he said was based on his years of association with JOSEPH LOMBARDI, HENRY NOYES and the rest of the Boston Italian element.

BS T-3 stated that there was definitely an organization among the Italians and although they used him on occasions, he never was accepted as a member because of his drinking habits and the fact that he was continually getting into trouble. He stated the old group was under PHIL BUCCOLA and consisted of JOSEPH LOMBARDI; JOSEPH BRUNO (deceased); FRANK CUCCHIARA; MICHAEL ROCCO; HENRY SELVITELLA, also known as HENRY NOYES; BIG BOZO CORTESE (deceased); ANTHONY SANTANIELLO (deceased); and an old individual named PEPINO who was connected with the American Finance Company located on Hanover Street, Boston, Massachusetts.
