On July 27, 1962, AARON M. KOHN, Managing Director, Metropolitan Crime Commission of New Orleans, Inc., advised that he had developed information that within the past several weeks JOSEPH MARCELLO and NICK MOSCA had taken over the operation of the Elmwood Plantation, 5400 River Road, Jefferson Parish.

It is the personal knowledge of Agents of the New Orleans Office that the Elmwood Plantation has, for the past eight years, been a moderately-priced restaurant of good reputation, catering particularly to ladies' bridge groups and ladies' club luncheons.

It has been previously reported that NOLA Printing Company, 530 Iris Avenue, Jefferson Parish, Louisiana, ceased operating as a race wire service on September 13, 1961. This company still publishes the Daily Sports Bulletin, which contains scratch information on horses running at various tracks throughout the United States.

In 1948, CARLOS MARCELLO was interviewed by Agents of the FBI. At that time, he advised he purchased the New Southport Club in Jefferson Parish in the Summer of 1948 for \$160,000.00 and that this club was a gambling establishment.

This office has under investigation the activities of a gambling casino in Jefferson Parish in the case captioned, "ALBERT J. SALZER, ET AL; THE CHESTERFIELD CLUB, ITAR-GAMBLING," Investigation has revealed that The Chesterfield Club located in Jefferson Parish operates casino-type gambling consisting of roulette, dice and blackjack.
