Re your FD-143 dated 12/4/64.

Since PH 705-C\* has produced only a very limited amount of information during the past 90-day period, your request to continue it for an additional 90-day period is not approved.

The Bureau recognizes this source has a potential to furnish significant criminal intelligence information and you are, therefore, authorized to maintain it for an additional 60 days. If PH 705-C\* does not furnish sufficient information to justify its continuance during the next 60 days, you should recommend that it be discontinued.

NOTE: This misur is located in the Philadelphia apartment of PH 672-C-TE. This top level informant is an admitted member of La Cosa Nostra. Source was installed on 8/7/64 when the PHO had the unique opportunity to make installation without CI's knowledge. One of the primary purposes for making installation was that information was developed that meetings might take place at the informant's residence, possibly at times that he would not be present. This source has not reported of any such meetings to date. It is of assistance in following the activities of the informant. However, it is felt that it has not been sufficiently productive to warrant Philadelphia's request to continue it for a 90-day period.

9. Continued.

As reported in weekly airtel summaries, Philadelphia on a day to day basis receives information regarding informant's personal activities and efforts by him to maintain his contacts with his associates. This source is primarily to check the movements and accuracy of informant's information and to afford coverage of meetings informant has with other La Cosa Nostra members. This informant's potential cannot be measured by specific examples of information furnished.

This informant serves to check on PH 672-C-TE and it is felt this source will in the future be able to furnish specific examples of value.

17. Remarks (By SAC):

As previously explained, the purpose of this installation is to have technical coverage on possible meetings between PH 672-C-TE and some of his associates who it is hoped will eventually appear at his apartment. It is, therefore, recommended that this source be continued because it has not had any breach of security to date and is being operated at no added cost to the division. UACB this source will be continued for a period of 90 days.
