A review of the file in this case reflects that the JCR is headquartered in New York City. The labor group of the JCR, Accion Sindical Independiente (ASI), is headquartered in Miami, under the leadership of CONRADO RODRIGUEZ SANCHEZ. RODRIGUEZ, a Cuban exile, is also a member of the board of directors of the JCR.

FLA
MM 1337-S, and other Miami sources, who are well informed concerning Cuban exile activities, have advised that the JCR in Miami, has engaged in no pertinent activities for more than 6 months. The ASI has been the more active branch of the JCR.

UACB, Miami is placing the JCR in a close status but will maintain the ASI in a pending status for a reasonable period of time.
