Enclosed herewith for the Bureau are the original and four copies of a letterhead memorandum captioned as above.

The confidential source mentioned in the enclosed communication is former PSI [redacted] 275 1/2 South Main Street, Akron, Ohio, who furnished the information to SA RICHARD G. PETERSON on 10/12/62. [redacted] was contacted on that date per his specific request. He is an employee of the Firestone Tire and Rubber Company, International Division, Akron, Ohio. It should be noted that [redacted] has extreme difficulty expressing himself in the English language.

OTHER 4

The Bureau will note that previous information obtained from [redacted] was furnished to the Bureau by CV let dated 12/1/61. At that time, [redacted] was residing at 1317 Harmon Avenue, Akron, Ohio. That information pertained to a letter he and a friend had received from Cuba, containing a message written in lemon juice to avoid detection by Cuban authorities.

This matter will be followed with [redacted], and the Bureau will be kept advised of all pertinent developments.

The enclosed letterhead memorandum is classified confidential inasmuch as the information therein may tend to compromise a source who may prove to be of future value to the Bureau.
