Authority granted to continue PH 714-C* for an additional 90-day period. If this source does not produce significant information during this period, you should give consideration to recommending that the source be discontinued.

NOTE: Angelo Bruno is the powerful La Cosa Nostra underworld leader in Philadelphia. This source is a CAT which is located in the automobile of PH 614-C-TE, a valuable top echelon informant of the Philadelphia Office who has on occasion allowed Bruno to use this vehicle. Philadelphia Office reports that during the past two-month period source has produced only limited information of value. It did report information concerning a trip Bruno made with Philip C. Testa, a "capo" in La Cosa Nostra, to Trenton, New Jersey, where they met John Simone, who is also a "capo" in La Cosa Nostra. Philadelphia Office reports that during the past two months source was operative on 12 occasions; however, in many of these instances persons in contact with Bruno did not appear to have any importance with respect to the Bureau's investigation of Bruno. The cost of maintaining this source is minimal. In the past Bruno has used this car when he did not want to be surveilled and therefore did not use his personally owned vehicle. In view of the potential of this source, recommend Philadelphia be authorized to continue source for an additional 90-day period.
