SOURCE ADVISED DURING EVENING OF THREE TWENTYFIVE LAST COSA NOSTRA CAPODECINA PHILIP TESTA MET AT EIGHTH AND CHRISTIAN STREETS WITH FRANK SINDONE, FRANK INNARELLA AND RALPH SCHWARTZ. NEITHER SINDONE NOR INNARELLA ARE MEMBERS OF LA COSA NOSTRA. ON DAILY BASIS THEY ARE ACTIVE IN OPERATION NUMBER LOTTERY. SCHWARTZ IS SUBJECTS OFFICE MANAGER AT PENN JERSEY VENDING CO.

AT ABOUT ELEVEN FIFTYFIVE PM, THREE TWENTYFIVE LAST PHILIP TESTA LEFT SEVEN FORTY CHRISTIAN ST. ENROUTE TO HIS RESIDENCE. FRANK INNARELLA DEPARTED AFTER INDICATING HE WAS GOING TO MEET WITH COSA NOSTRA MEMBER FRANK MONTE.
