MADELINE COSTELLO arrived Miami on Eastern Airlines flight 841 from Philadelphia at 12:20 a. m., 4/12/65. She took a cab to her residence, 12468 N. Bayshore Dr., N. Miami.

Surveillance maintained on COSTELLO residence on 4/12/65 and MADELINE COSTELLO was not observed to leave the house and no one visited the house except a painter and CHARLES COSTELLO's boat captain.

Former PCI [redacted] (protect identity) advised that MADELINE COSTELLO flew North last week to take CHARLES COSTELLO's mother back to Trenton, N. J. He advised that MADELINE returned to Miami on the evening of 4/11/65. PCI stated that no one has visited the COSTELLO home since he was last contacted, except a painter who is doing work inside the COSTELLO home.

A review of reservations for flights to Caracas, Venezuela, on Pan American, Varig and Viasa Airlines for the remainder of the week disclosed no reservations for the subject under the name BRUNO or ANNALORO.

Stops have been placed on Pan American, Varig and Viasa Airlines for future reservations to Caracas by the subject.
