As stated in last week's airtel, ROSSELLI left Los Angeles for Las Vegas on 1/18/65. No information was received that he had returned to Los Angeles. However, on 1/26/65 information was received from the Los Angeles Police Department that at 11:30 p.m. on 1/25/65 ROSSELLI was observed leaving Los Angeles via United Airlines for Las Vegas. He was traveling under the name of J. GOODMAN and was accompanied by MARTIN GOODMAN. On 1/29/65 LA 4268-C advised that MARTY GOODMAN is engaged in real estate dealings and that last summer he allegedly handled a million dollar land sale. The real estate involved was not in Los Angeles but was generally in the Los Angeles area. Informant said that GOODMAN is a heavy gambler, likes to play golf and is quite friendly with ROSSELLI, MAURICE H. FRIEDMAN and IRVING J. LEFF.

Information was previously reported in this investigation that on 12/7/64 ROSSELLI left Los Angeles and was not known to return to Los Angeles until 12/14/64. Recent inquiry at the Jayne Meadows Travel Agency revealed that on 12/6/64 ROSSELLI purchased a ticket for Chicago, Illinois, on Continental Airlines. On 1/28/65 it was ascertained that on 12/7/64 ROSSELLI left Los Angeles at
