GEORGE HOPKINS, Manager, Glen Towers Apartments, advised that he did not observe ROSSELLI around the apartment from about last Sunday until the morning of February 12, 1965. He said, however, that on February 10, 1965, he observed ROSSELLI's car in the garage for the first time since last Sunday. He also observed a girl around the apartment since Wednesday and he believes, but does not know for certain, that she has been staying in an apartment on the same floor as ROSSELLI's apartment. On February 12, 1965, HOPKINS examined a photograph of KATHY HORDEN and stated that she is the girl he has seen around the apartment. It would appear that HORDEN is probably again living with ROSSELLI.

The Las Vegas Office received information from LV 10-C that on January 30, 1965, a Miss CHRISTEY attempted to contact ROSSELLI at the Desert Inn Hotel and left her telephone number as 736-3161. As previously reported ROSSELLI left Las Vegas for Los Angeles on February 1, 1965.

The Las Vegas Office also advised that information was received from the Nevada Gaming Control Board that ROSSELLI was in Reno, Nevada, on February 9, 1965, in the company of MAURICE FRIEDMAN, and that the purpose of their presence there was not known.
